At the outset Prof. Gupta welcomed all the members of the Board of Studies for School of Management and provided a brief overview of the action taken on the resolutions of the last meeting. The agenda items along with their narration and relevant annexures were circulated to the members on 23rd March 2022 over email and were subsequently transacted.

1. To confirm minutes of the 2nd meeting of the Board of Studies for School of Management held on 13th October 2021.

Resolved that the minutes of the 2nd meeting of the Board of Studies held on 13th October 2021 and circulated to all members on 27th October 2021 be confirmed.

2. To recommend the curriculum/syllabi for 4th semesters of the MBA Department for the batch 2020-22 and beyond.

Resolved that the curriculum/syllabi for the 4th semester of the MBA Department for the batch 2020-22 and beyond be endorsed to the Academic Council for its approval after the inclusion of Financial Engineering as one of the electives under Finance Specialization. The members further appreciated the following aspects of the curriculum:

- a) Introduction of seven emerging courses including Advanced Digital Marketing, Corporate Taxation, Behavioural Finance, Human Resource Analytics, Business Intelligence and Applications, Cloud Computing for Managers and Artificial Intelligence for Business Managers to equip students with industry relevant skill sets.
- b) Inclusion of training on software packages like Primavera, Microsoft Project, Hubspot, Salesforce, Zoho and Microsoft Power BI as part of regular coursework.
