The Convener welcomed all the members present and informed them that this committee has been constituted in accordance with the UGC Regulations of 2009 to curb the menace of ragging. To start with, the Convener asked Dr. Sarabdeep Singh, Convener of Anti-Ragging Committee to read out the salient clauses viz. 3, 6 and 9 of UGC Act to apprise everyone about 'what constitutes ragging', 'action by Committee/Head of the institution' and 'punishments to be given to the ones involved in ragging'. In addition to this, he also read out the changes in the rules of ragging as per the UGC Act. The convener gave following details of the action already initiated/being initiated to contain ragging and freshers in the college:

- a. Central Anti-Ragging Committee and Anti-Ragging Squads have been constituted in the college.
- b. Revised procedure for students to file online Anti Ragging Affidavit: In pursuance to the Judgment of the Honorable Supreme Court of India dated 8.5.2009 in Civil Appeal No. 887/2009, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" and in compliance of the 2<sup>nd</sup> Amendment in UGC Regulations, it is compulsory for each student and his/her parent/Guardian to submit an online undertaking each academic year at either of the two designated web sites, namely, <https://www.antiragging.in> and <https://amanmovement.org>. A step-by-step guide-on-How-to-fill-Online-Anti-Ragging-Undertaking and certain information about Institute shall be required, is being provided in the **Annexure-1**. After filling the form successfully, the received confirmation email should be printed and submitted to the Institute.

- c. To deter senior students from indulging in ragging, posters giving the details of the punishments applicable under rules are displayed at prominent places and on all the notice boards/digital signage.
- d. Names and telephone numbers of the members of Central Anti-Ragging Committee are being displayed on the notice boards at various places for the information of newcomers and to ensure that no ragging activity takes place.
- e. Staff members have been nominated for each of the student buses. They travel on the buses and ensure that no ragging activity takes place.
- f. Undertaking is being taken from all the staff members to report incident of ragging, in case they notice it anywhere in the campus.
- g. The security staff at the college gate has been asked to check the ID cards of the students while entering the gate and should not allow anyone to go out before the scheduled college hours without permission.
- h. Student members were asked to be vigilant in their departments, advise the potential trouble creators against the ragging activities and inform the committee of ragging activities, if any.

All faculty members endorsed the view of convener and that they would keep their faculties present in the corridors and classrooms during the working hours so that the senior students should not disturb the freshers.

The Convener desired awareness on the ragging menace to be spread among the seniors by all HoDs in the respective departments and actions to be taken at all levels to make this academic year also a ragging free year.

There being no other points from anyone, the meeting was concluded.
